CITY of KAWARTHA LAKES – COUNCIL OF THE WHOLE Deputation – 2023-9-26

My name is Shelagh McFarlane & i am from Guelph, Ontario.

Angel asked me to present some information today that supports this petition and I am honoured to stand beside her.

I met Angel about 6 weeks ago after I saw her deputation that went viral *GLOBALLY.* She told you that the public hadn't had an opportunity to be heard with respect to this "rezoning".

As she mentioned, when she took this petition door to door, she discovered, **nobody** *knew anything about it OR where it* **came** *from*.

The same thing is happening in every town and, being well versed in municipal government, I came up here to help her understand the public/private partnership *fraud* that is happening in this very room *and in every CITY HALL*.

A public/private partnership is a legal creature that looks like government, but it's not.

Chances are only the Chief Administrative Officer and myself know that this room is actually a UN Field office and we are in international jurisdiction right now.

And why the only thing you can talk about here is sustainable development & climate change.

In this UN partnership, everything can be done by the signatures of only 2 men – the Mayor & the CAO.

COVID proved these 2 officers can not only call a local emergency any time they want but they can put a needle in your arm USING ONLY A BY-LAW. Like a PARKING TICKET.

So you better know who they work for.

Just a bit about my background, in 2014 I ran for Ward councillor in Kincardine to stop Ontario Power Generation from burying nuclear waste beside our Great Lakes.

I discovered there was a public/private partnership agreement Larry Kraemer committed Kincardine to in a secret mayor meeting.

And I learned that public/private partnerships are UN creatures – here to bring us de facto global government in lieu of our rightful sovereign powers.

So this direction is TO the Mayor & elected councillors,

- There is concrete evidence that you are sitting in 3 different legal capacities

 public, private & international and with no authority to sign for any of
 them. I highly recommend you seek independent legal advice.
- these petitioners, & many, many more understood they were electing you to form the public office, and, you will be asked to produce your oaths of office if you are sitting in here stating that you hold public consent.
 If you have chosen to act in another capacity, they need to know.
- 3. Until your allegiance is proven, these people state that their public & private property are *NOT included in "Schedule A "of this By-law rezoning* and therefore, are not subject to this service agreement.
- 4. No one is obligated to obey de facto possession of sovereign governing powers, nor participate in fraud.

Due to the gravity of this situation, a foreign coup d'état, this requires your *IMMEDIATE ATTENTION, Mayor & Councillors:.*

You are not authorized to move forward with any CITY motion until all of you have met with your constituents to their satisfaction.

Please note, "*Failure to answer IS an answer*" so if you refuse to meet with them, it will indicate you have abdicated your elected duty to act as their public trustee.

And therefore, *you hold no representative authority or jurisdiction in this room or otherwise*.

If this is true, they will decide where they go from here.
