About the POGG Protocol: Emergency Estate Redemption Restoring Local Self-Governance in Peace

Purpose:

To educate elected Mayors and Councillors on how to correct the legal conversion of their authority, and return to governance in truth, trust, and lawful stewardship, rooted in the Doctrine of Peace, Order, and Good Governance (POGG).

Background: The POGG Publications

All POGGs were written to support Mayors, Councillors and constituents for the transition back to local autonomy, to educate them about the **hidden trust/tax structure underneath their local economy**, and a way to correct it all in the spirit of peace, friendship and forgiveness.

All POGG's reveal the following problems that need correcting:

- 1. Canada's governments are now corporations doing business and causing harm,
- 2. Pretending to be "government" is called "misrepresentation" or "fraud", and
- 3. Once proven, any deception vitiates all every past, present, and future "agreement."

The POGG Primer: Ending the Public/Private Partnership Fraud (October 2023)

The Primer briefly describes how the *United Nations (UN) Agenda2030* took over every town in Canada using the locally elected Mayors and Councillors.

Public officials were partnered with private, municipal corporations, and commercial code was used to make Mayors the CEOs of corporations, instead of trustees for the people.

Governance was usurped by the Municipal Act (private commercial code) that grants an unelected CAO and CEO **FULL CONTROL of the area**, who care **VERY LITTLE** about your local needs. This led to:

- deception about who's "administrating" local trust accounts and deciding your future,
- a foreign Agenda implemented deceitfully, strapping towns with huge municipal debt, and budgets for unwanted services, consultants and harmful goals, and
- breaches of legal, lawful and spiritual principles which can only lead to further suffering for all, especially the children.

- POGG #2: The Local Solution -

The POGG Protocol: Emergency Estate Redemption (July 2025)

I wrote this publication in *two different formats - both outline the five deceptions* used to hijack local governance in Canada, and the recommended solutions for each one. Emergency Redemption is the simple, peaceful correction for all five deceptions at once.

- (a) <u>Written in Legalese</u>: (20 pages)... explains each fraud/breach in financial, legal and technical terminology. This document includes diagrams, pertinent legislation and legalese definitions. This format can be submitted as evidence for court, if needed.
- (b) <u>Written in Plain Language</u>: (8 pages)... summarizes the five deceptions in simple words, and includes simple letters to your Mayor and the municipal Clerk seeking clarification of who you are (and who they are) in this municipal system.

- The 3 Core Steps of The POGG Protocol -

Step 1: Education and Awareness

The POGGs can be used to teach people about their registered trust accounts, and how to establish non-municipal standing in peace.

Learn how local men and women became municipal property:

- birth registrations created a public trust-based Estate with the Crown,
- municipal registration transferred Estates to private global corporations, and
- you unknowingly sign and pay tax for this "municipal person", instead of claiming your Estate.

Step 2: Emergency Redemption for Public Officials

This is the *PUBLIC (Emergency) Redemption process* which invites Mayors and Councillors to voluntarily:

- re-oath under public trust principles,
- re-affirm service to the local people, not corporate (municipal) fictions, and
- perform their duties as fiduciaries and trusted servants, not CEOs for a foreign franchise.

This process is clarifying to the municipal Clerk who you are (your status), and reassigning the legal obligations for the public account back to the Mayor, as the designated public trustee, elected specifically to administrate it on your behalf.

Step 3: Estate Redemption for Private Men and Women

This is the *Private (Estate) Redemption process*. People can do this step if their Official chooses to remain silent and/or refuses to re-oath.

This step gives lawful notice to "the system", and removes the public trust account from all administrative presumptions, and from being used to fund any UN Agenda sustainable development goals.

- ⇒ This approach is not a "protest"—it's a call for truthful disclosure, lawful correction of standing, and a spiritual return for all parties.
- ⇒ This solution is not just a "theory"—it explains the hidden trust structures we've been secretly and economically tied to, and to correct these in peace.
- ⇒ The end goal is not about "money, power, control or revenge"—it's about forgiveness, uniting with your neighbours, and being of genuine service to others.

EMERGENCY DECLARATION FORM

Whereas the Emergency Management and Civil Protection Act, R.S.O. 1990, Chapter E.9, Section 4(1) states:

The head of Council of a municipality may declare that an emergency exists in the municipality or in any part thereof and may take such action and make such orders as he or she considers necessary and are not contrary to law to implement the emergency plan of the municipality and to protect property and the health, safety and welfare of the inhabitants of the emergency area.

And whereas the outbreak of a communicable disease, namely COVID-19, constitutes a danger of major proportions that could result in serious harm to persons within the entirety of the geographic area of the jurisdiction of the City of Guelph.

Therefore I, Cam Guthrie, head of Council of the City of Guelph, do hereby declare that an "Emergency Exists" within the boundaries of the City of Guelph.
