About the POGG Protocol: Emergency Estate Redemption

In 2023, I wrote *The POGG Primer: Ending the Public/Private Partnership Fraud*.

It briefly described how the *United Nations (UN) Agenda21* took over every town in Canada using the locally elected Mayors and Councillors.

I recommend you *read the POGG Primer first,* as an entry point to this one. All POGG's were kept short for expedience, and to simplify a complicated problem.

The POGG Protocol: written in two languages

Both *Emergency Estate Redemption* formats outline the *five deceptions* used to hijack local self-determination in Canada, *and the solutions* for each one.



(a) <u>in Legalese</u>: (20 pages)... explains each fraud/breach in financial and technical language. This document can be submitted as evidence for court.

(b) <u>in Plain Language</u>: (10 pages)... describes them in simpler words, so anyone can learn this information to achieve financial and local peace.

The Three Steps for Peaceful Redemption

Step 1: Education and Awareness

... understanding the truth about the public/private trust accounts registered in your name, and the redemption steps.

Step 2: Emergency Redemption for Public Officials

... is the *PUBLIC Estate Redemption process* which invites Mayors/Councillors to voluntarily re-oath as your trustees, to redeem the Estates on your behalf.

Step 3: Estate Redemption for Private Men and Women

... is the *Private Estate Redemption process* which gives lawful notice to the "system", and corrects the presumption that you abandoned your Estates.



- ⇒ This Protocol is not a "protest" it's a call for truthful disclosure, lawful correction of standing, and a spiritual return for all parties
- ⇒ The end goal is not about "money, power or revenge" it's about forgiveness, uniting with our neighbours, and being of genuine service to others
- ⇒ This Protocol can be used by anyone in any town/city all across Canada.



- Overview -



What you're about to learn in a nutshell

- 1. Men and women have been captured in a <u>money system</u> founded on the birth certificate issued when we were born. That birth certificate represents a type of "money" in this economic system, but we were never taught how to redeem it and use it correctly.
- We've also been captured in a <u>legal system</u> masquerading as law. We're being tricked by Legalese "weasel words" - words that have multiple meanings.
 We don't understand the legal system language, although the words look familiar.
- 3. Our governments have been captured in <u>both</u> <u>systems</u>, especially our local government Office (of the Mayor). Governments have become corporations instead of institutions of trust, and the Officials we elect to represent us, swear to "re-present" foreign, corporate Agendas instead.

<u>POGG is a Peaceful Economic Restoration based on two redeeming processes:</u>

- (a) **Reclaim the "Public" Person** The *Emergency Redemption* invites sitting Officials to willingly move to their proper public role to return to service as public fiduciaries/administrators, not enforcers of foreign municipal policy.
- (b) **Redeem the "Private" Man** The **Estate Redemption** walks through how people can now independently claim their trust accounts and private standing.

Both processes are legal and spiritual remedies, founded in friendship, forgiveness and peace

... to correct the Five "Municipal" Deceptions:

- 1. Election interference how we lost our trust institutions to the CITY corporations
- 2. Breach of trust how we lost our "trust funds" to foreign goals and Agendas
- 3. Breach of public security/safety how our local "money" is pledged to fund unsafe technology and international agreements
- 4. No courts of law available to help us but where we can go instead, and
- 5. No peace officers to come to our defence but what else we can do.

The POGG Protocol is the simple way to fix a "municipal" problem.

Officials swear to serve the local people,

or they will be replaced with someone who will.

Our children are counting on us... We have a Duty.



Chapter 1 What Went Wrong with Our Local Elections



What happened...

Imagine if you thought you voted for someone to represent you — but it turns out you voted for an *Officer of the United Nations (UN)*. That's what happened, all across Canada.

Mayors and Councillors now "represent" private *non-government corporations* e.g., The *Corporation* of The *Town* of Huntsville.

These corporations run your town like a business franchise, following foreign goals (like UN Agenda 2030), instead of taking care of local needs.

What can we do?

The right way to "undo" what was done is to correct this "business" mistake - Officials were elected to represent you and your area, not a global franchise.

As soon as they agree to correct their mistake, there's an easy way to fix everything else in your town... like the roads, schools, food markets, and "taxes."

- <u>Operation: POGG</u> - Lawful Redemption for Mayors/Councillors

Operation: POGG outlines how all elected Officials can safely exit the Municipal Act's corporate structure simply by invoking the local trust institution (Office of the Mayor).

- **1. Officials take the proper oath** and agree to work for the men and women who elected them, not for the (provincially owned/controlled) Municipality or UN-elected CAO.
- 2. Your Mayor (with granted fiduciary powers) can **restore local economic independence** (a sovereign bank), full regulatory control for your area, and peace.
- **3.** Your Mayor (with granted regulatory powers) can **cancel harmful international memberships, gross administration costs** (e.g., Sunshine Salaries), and start forensic audits on all accounts and assets.
- **4.** Your Mayor (with restored administrative powers) can ensure all your local services (like water, schools, or health care) continue unaffected while your town transitions, and all **your bills (including taxes) paid directly from trust funds**, not your pocket.
- **5.** Your town can immediately **start Town Hall meetings** to help feed, home, and educate every man and woman in need, or suffering from financial abuse and By-law tyranny.
- **6.** A new local election can be called, using a new transparent voting system.

Restoring sitting Officials to peacefully guide this process ensures that no man, woman or child is left behind, and your town exits the UN Agenda in a controlled fashion (see page 10).

Everything corrected and restored without paying or borrowing a dime! Wow!



- Chapter 2 -A Trust Was Broken, But We Can Fix It



Did You Know you have a Trust Account No One Told You About?

When you were born, the government created an account in your name. It's like a savings bond/insurance policy or debit card, designed to pay all your bills.

The value of it is your stored labour, and your name was converted to **ALL CAPITAL LETTERS (ALL CAPS)** to indicate it's registered into the corporate system.

But Guess What?

You can use that account to pay ALL your bills - like rent, mortgage, groceries - AND it clears all your "debt"!

How the trust and the breach were set up

- 1. You were registered into a system that registered you as a business account (ALL CAPS), not a living man or woman;
- 2. Trust institutions (like the Office of the Mayor) were replaced by corporate franchises, and you became pledged to the system using this ALL CAPS identity;
 - This allowed public trust accounts to be used for things you never agreed to—like foreign policies, private developments, and unsafe technology; and
- 3. Because the legal system is also a business (for Crown property administration), there's been no way for us to correct this legal mistake and misunderstanding ... until now.

How Registration Transfers Power (to the Crown or to a Municipality)

When something is registered—like a birth, home, or vehicle—it moves from your *private care* into a *public system* managed by the State. When your birth was registered, the **NAME** (in ALL CAPITAL LETTERS) became a public trust "held" by the government. While this may seem harmless, it quietly shifted control away from you.

Birth, marriage, and death certificates are considered Crown property *unless you correct the legal presumption*. When you do, you reclaim your true identity and estate—and live free of mistaken roles and financial burdens.



- Chapter 3 -



Our security was meant to protect us, not harm us

The Pledging (Monetary) System - "Public Securities"

Governments, if they don't operate as public institutions, will "service" the area to make money, not in ways that the people necessarily want —and these *private service agreements* have caused serious harm to both people and their property.

The Money Deception... using the "person"

Unfortunately, when trapped in a commercial system, people get treated like financial assets, without their knowledge. Your birth (event) registration became a type of financial contract, creating a "person", and making this "person" responsible for undisclosed municipal debts (see "person" in the Legalese version).

Municipalities then use the registered "person" to borrow money, and secretly launch their own municipal Agenda, i.e., installing unsafe or unwanted technologies without public consultation, understanding or permission.

So how can we escape what seems to be involuntary servitude?

The way forward is not punishment or law suits, but peaceful correction: to reclaim your power, and help restore safety and care in your town for everybody.

You can send a letter to the Mayor expressing how you want your public/private Estates to be administrated, because there was a mistake in how you were registered. (see page 9)



- Chapter 4 - Where Did the Real Courts Go?



Why you feel unheard in court...

Most people feel confused and dismissed in court—it's because they've been brought into a legal (and monetary) world that doesn't (and can't) recognize them as living men or women.

What is a real "Court of Law"?

A court of law is one with **jurisdiction (granted authority) over the parties and the subject matter**. The courts we have now only have jurisdiction over CROWN entities, and rule according to CROWN statutes, not by conscience or consent.

How and when we lost our local "People's" Court

Our lawful courts were "incorporated" into the CROWN's Legal System. The CROWN uses civil procedures, a foreign language, and assigned roles that only apply to corporate or fictional identities (like the NAME in ALL CAPS).

CROWN courts aren't truly "public" nor "government"—they're commercial tribunals for settling contracts and securities, not subject matters like land, trust, or family.

Today, the closest we have to a "court of law" is the Small Claims Court in every town. The sitting judge rules on the private issue (contract) before him - he's not to "rule" according to a statute, or about a CROWN subject or "Subjects."

Small Claims Court historically was the "People's Court" (non-Crown), and it's the closest we have for "man-to-man" resolution.



- Chapter 5 -Your Right and Duty to Declare a POGG Local Emergency



If your town is being controlled by foreign powers implementing rules and regulations against the people's consent, you can invoke POGG Emergency Powers.

POGG Emergency Powers are defined in both "Law" and "Legal":

1. Doctrine of Law:

If a government is not protecting *peace, order, and good governance*, it loses its legitimacy and authority. If or when this happens, you are to peacefully disobey and remove who (and what) no longer serves.

2. Legal Clause in CROWN Legislation:

Canada's Constitution (Section 91) gives FINAL emergency authority to the "CROWN." *However*, this "CROWN" clause centralized control under the "CROWN" and Her/His corporate-trust system—not the people.

In either case, if there's a serious threat to life or freedom, and **NO ONE IS ABLE TO HELP**, you don't need permission to immediately protect your family and property.

We All have the Authority and Duty to Declare a Local STATE of Emergency

- 1. Contact any (or every) judge, justice of the peace, or retired lawyer in your area. Talk to every family member in these professions.
 - Show them **The POGG Primer and Protocol** and ask them if redemption is a way for us to exit a global Agenda simply and peacefully.
- Contact every candidate from your last local election. One of them can challenge the man/woman they ran against, and step in if there's a Local STATE of Emergency and you are being harmed.



Since ALL local government seats are **VACANT**, EVERY previous Candidate *has a duty to stand* and hold the seat for their area.

3. **If no response,** do your own Estate Redemption process. You can take peaceful steps to remove your name and trust from the municipal record.

Estate Redemption is done with courage & kindness... in the spirit of friendship, forgiveness & peace.

Example: A Peaceful Notice of Correction of Standing and Trust

Dear Mayor, write this as a co-user of a registered public account I wasn't aware of until recently.
It's been revealed to me that the NAME we all carry in all capital letters—created through birth registration—is a registered Estate, a commercial trust account that exists separate from who I am as a living man/woman.
It's also been revealed to me that as "Mayor", the fiduciary duties of this public account lie with you. Are you not duty-bound to administrate this for any and all public obligations? Do I forward bills (to the NAME) to you directly? And if not you, then who do I speak to?
Continued usufruct constitutes financial abuse, as I wish to be released from further presumed joinder, municipal obligations and/or financing of any UN Agenda2030 sustainable "goal" causing harm.
Please contact me immediately to discuss. Thank you, in peace and redemption,

Example: Mistake with respect to the registered account/NAME
Dear (Clerk) This account is not me or mine. I'm not authorized to open or sign for it, and doing so would make me complicit in identity and public security fraud.
As I am just finding out this information now, please direct all correspondence re. this account to Mayor, as the designated trustee for it. If I'm mistaken, please contact me immediately.
In closing, I never knowingly meant to act as owner, trustee or debtor for this account/NAME and any past trespass was done in error, under duress, or without disclosure.
don't consent to any municipal statute used to define my "civil" obligations without me knowing, or my estate used to fund any UN Agenda2030 sustainable "goal" causing harm.

Coming Down The Pike... Get informed, Be prepared.

1. Seated elected officials will be sworn in under the **public oath.** This will establish geographical **trustee authority**. If they refuse, there will be a public election to replace them (see #6):

Mayor becomes Chief Executor of local Public Trust(s)
Counsellors to form Board of Trustees

Lawful Redemption: Private status revoked: Liability for prior acts of negligence waived.

Public status invoked: Under full liability for harm, loss or injury caused.

- 2. "Re-public" the local governing institution:
 - a. **Fiduciary Authority Restored**: Local Treasury established. All property taxes, fees & securities diverted to trust accounts independent of CITY, WEF & central banking system.
 - b. **Judicial Authority Restored:** Sheriff appointed, county courts established, peace officers sworn. (public oath issued for Municipal police/By-law officers if they choose to remain)
 - c. **Regulatory Control Restored:** All PPP agreements & UN/WEF financing commitments terminated; forensic audit on municipal accounts/contracts; "Pause" on all CITY By-laws.
- Unincorporate "all things local" from the UN CITY STATE corporate structure (terminate membership & association with non-government "Municipalities").

Fraud (non-disclosure) avoids/nullifies all past, present and future obligations.

- 4. All **Municipal service contracts** reviewed; necessary services maintained (water, sewer, transit, health, schools etc.) **ALL your municipal services/fees to be paid from your Local Treasury ONLY**.
- 5. **"Mentor counsellors"** (local men/women wanting to step up to restore the local governing level) work alongside their public trustees (Ward Counsellors) as qualified mentors for the "re-public" transition *OR* to step in as "temporary public trustee" if there's a resignation.

Ward Counsellors and their mentors will determine **Town Hall** locations, size and services. Immediate Treasury funds available for housing, food, health care, seniors, small businesses, daycare/education, transportation, cost of living assistance etc. *All will be homed & helped*.

6. A **new public voting system** is in development. Constituents will elect/appoint their public trustees directly, not by proxy for the resident, body corporate or legal person.
